Proposal: Variation of Condition 7 of planning permission C10/1095 to allow existing annexe to be used as a holiday let.

Location: Riverside Tearoom, Orford Quay, Quay St, Orford. IP12 2NU

Proposal: Extension of seating deck to existing tearoom and associated alterations.

#### **Application No: C12/0408**

Location: Orford Lodge, Newton Broadway, Orford. IP12 2AF

Proposal: Erection of single storey & two storey rear extensions.

Cllr Pilkington gave details regarding the application and raised concerns. There was a brief discussion and it was Agreed that the Council would Object to this application on the following grounds:-

- The proposed extensions would not be in keeping with Local Plan Policies
- It was felt that the proposal would be an over-development of the site
